Shareholder Communication and Shareholder Meetings Policy Lindsay Australia Limited ACN 061 642 733

1. General

As an ASX listed company, Lindsay Australia Limited, together with its related parties (**Company**) is required to comply with ASX Listing Rules and relevant laws governing the manner in which it conducts its business.

The board of the Company has adopted the ASX Corporate Governance guidelines as amended from time to time, that require the Company to disclose how it facilitates and encourages participation at meetings of security holders.

2. Application of this Policy


The Company aims to communicate with clarity, accuracy and in plain language with its stakeholders including shareholders, this applies to direct engagement with shareholders, and in information released by the Company to the market generally. The Company will place all periodic reporting, investor briefing materials, business or market updates and price sensitive disclosures on the ASX Markets Platform in accordance with the ASX Listing Rules. The Company produces half-year and full-year financial reports and an annual report in accordance with the requirements of the ASX Listing Rules and the Corporations Act, these financial reports are available on the Company's website www.lindsayaustralia.com.au. The Company will comply with all applicable laws and accounting standards and make material disclosures clearly and concisely in its financial reports and market disclosures. Compliance with the Company's Continuous Disclosure Policy supports the timeliness of market reporting by the Company.

The Company is committed to facilitating participation by shareholders at shareholder meetings including the Annual General Meeting. Information pertaining to such meetings, and Notices of Meetings will be placed on the ASX Markets Platform in accordance with the ASX Listing Rules. Shareholders are afforded the opportunity to attend and participate in meetings including online and put forward questions at the meeting or direct questions to the Company prior to the meeting. The company auditor is also present at the Company's Annual General meeting to respond to questions regarding audited financial reports.

In determining any resolutions on substantial matters to be conducted at shareholder meetings, all such resolutions will be determined by a poll.
